WHEREAS, the Department of Education Alaminos City through the **Basic Education – Learning Continuity Plan (BE-LCP) Bayanihan Act 2 FY 2020 Flexible Learning Option** is in need of contractor/supplier for the **Procurement of Tablets for Kinder to Grade 12 Learners on Basic Education – Learning Continuity Plan (BE-LCP)** of Alaminos City Division, Alaminos City, Pangasinan;

WHEREAS, that this committee recommends the use of Alternative Methods of Procurement (Small Value Procurement) whereby the procuring entity directly request for quotation with at technically, legally and financially capable suppliers/caterers pursuant to the provision of Section 52.1(b) and Section 53.9 of Revised IRR of R.A. 9184 where the amount does exceed the thresholds prescribed in Annex “H” of the Revised IRR and resulted the following:
