WHEREAS, the Department of Education Alaminos City through the **Basic Education – Learning Continuity Plan (BE-LCP) – Provision of Learning Resources (LR's), FY 2021 GAA Flexible Learning Options** is in need of contractor/supplier for the **Procurement of Tablets for ^{G4} to Grade 10 Learners on Basic Education – Learning Continuity Plan (BE-LCP)** of Alaminos City Division, Alaminos City, Pangasinan;

WHEREAS, that the Bids and Awards Committee agreed to invite at least three (3) suppliers of good standing which was posted at Phil-GEPS for three (3) consecutive days, with PhilGeps Reference No. 7665702 and in response to the said posting, only one (1) suppliers submitted his quotation;

WHEREAS, that Small Value Procurement under Section 53.9 of the 2016 Revised IRR of RA 9184 shall not exceed the thresholds prescribed in Annex H and the BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof, and this resulted the following:


