RECOMMENDING APPROVAL FOR THE PROCUREMENT OF LOCAL AREA NETWORK (LAN) AND CLOSED CIRCUIT TELEVISION (CCTV) BE UNDERTAKEN THROUGH ALTERNATIVE METHODS OF PROCUREMENT (SMALL VALUE PROCUREMENT) IN ACCORDANCE WITH SECTION 53.9 OF THE 2016 REVISED IRR OF R.A. 9184.

WHEREAS, that Procurement of Local Area Network (LAN) and Closed Circuit Television (CCTV) for four (4) Division Office Building must be undertaken;

WHEREAS, that a funding requirement for Program Support Fund for Network Infrastructure of Schools Division Office was received amounting to One Million Pesos (P 1,000,000.00) to upgrade the existing internet capability and the CCTV for security purposes;

WHEREAS, that the Bids and Awards Committee (BAC) agreed to recommend the use of Alternative Methods of Procurement, particularly, Negotiated Procurement-Small Value Procurement considering that the conditions required by law for the use of alternative methods of procurement are present;

WHEREAS, that Small Value Procurement under Section 53.9 of the 2016 Revised IRR of RA 9184 shall not exceed the thresholds prescribed in Annex H and the BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;


WHEREAS, the bid amount for the above said project is **NINE HUNDRED EIGHTY-FIVE THOUSAND FIVE HUNDRED PESOS (P 985,500.00) ONLY** and this resulted below:

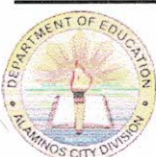
