**BAC RESOLUTION RECOMMENDING THE APPROVAL FOR THE PRINTING OF LEARNING RESOURCES FOR THE IMPLEMENTATION OF BASIC EDUCATION – LEARNING CONTINUITY PLAN (BE-LCP) BE UNDERTAKEN THROUGH ALTERNATIVE METHODS OF PROCUREMENT (SMALL VALUE PROCUREMENT) IN ACCORDANCE WITH SECTION 52.1(b) AND SECTION 53.9 OF R.A. 9184 AS AMENDED.**

**WHEREAS**, the Department of Education (DepED) Alaminos City Division requested the printing of Learning Resources for the implementation of Basic Education – Learning Continuity Plan which must be immediately undertaken;

**WHEREAS**, that the Bids and Awards Committee (BAC) agreed to recommend the use of Alternative Methods of Procurement, particularly, Small Value Procurement considering that the conditions required by law for the use of alternative methods of procurement are present;

**WHEREAS**, that the Bids and Awards Committee agreed to invite at least three (3) suppliers of good standing which was posted at Phil-GEPS for three (3) consecutive days and in response to the said posting, two (2) suppliers submitted their quotation;

**WHEREAS**, that this committee recommends the use of Alternative Methods of Procurement (Small Value Procurement) whereby the procuring entity directly request for quotation with at technically, legally and financially capable suppliers/caterers pursuant to the provision of Section 52.1(b) and Section 53.9 of Revised IRR of R.A. 9184 where the amount does exceed the thresholds prescribed in Annex “H” of the Revised IRR;

**WHEREAS**, that the Small Value Procurement will not result in the splitting of the contracts as indicated in the attached Request for Quotation as a proof for the conditions provided in Section 52.1(b) and Section 53.9 of the IRR;

**WHEREFORE**, the **BAC RESOLVES** as it is hereby **RESOLVED** to recommend immediate approval for the Printing of Learning Resources for the Implementation of Basic Education – Learning Continuity Plan (BE – LCP) in accordance with Section 52.1 (b) and 53.9 of IRR of R.A. 9184 which is Alternative Methods of Procurement, Small Value Procurement.


