CONTRACT AGREEMENT

THIS AGREEMENT made on the 21st day of April, 2021 between the DEPARTMENT OF EDUCATION, ALAMINOS CITY DIVISION, Alaminos City, Pangasinan, Philippines, represented herein by its Schools Division Superintendent, DR. LORNA G. BUGAYONG, CESO V (hereinafter called "the Entity") of the one part and GR8 Merchandise & Trading represented herein by its Proprietor, MS. FLORDELIZA G. RAFANAN, with office address at Casabaan Norte, Sumabnit, Binalonan, Pangasinan, Philippines (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited contractors/suppliers to Bid for the Procurement of Tablets for Kinder to Grade 3 Learners for Q3 to Q4 on Basic Education Learning Continuity Plan for Public Schools of Alaminos City Division, Alaminos City, Pangasinan and has accepted a bid of the lone Supplier in the sum of One Million Eight Hundred Thirty Nine Thousand Five Hundred Sixty Five Pesos (Php 1,839,565.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract;
4. The Entity hereby covenants to pay the Contractor/Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract;
