1. According to the Implementing Rules and Regulation (IRR) of Republic Act (RA) No. 10588 otherwise known as Palarong Pambansa Act encourages the conduct of athletic meets at the District, Division, and Regional Level, this Office shall conduct the 2024 Division Athletic Meet on February 1-3, 2024 at Alaminos City National High School.
2. The final checking of athletes' and coaches' documents shall be held at the SDO Library Hub on January 30-31, 2024 by the Division Screening and Accreditation Committee. For elementary athletes, the cut-off birthdate is January 1, 2011, and January 1, 2006 for secondary athletes.
3. Participating Schools must have a sports club duly registered to be qualified to join the division meet and advance to the next level of competition.
4. Tournament managers, technical officials, and coaches are required to attend the refresher course on January 29-31, 2024 at Alos National High School.
5. All officers and members of the Division Association of Sports Coordinators and male technical officials are requested to report at Alaminos City National High School on January 31, 2024, for the preparation of the playing areas and the venue of the opening program.
